

Dis-traction

at the Wheel

Summer, by definition, seems like it should include the word "distraction." Our schedules are disrupted by new routines, whether it be getting our kids to summer camp or prepping for summer vacations. Our attention is "dis-tracted." Most definitions of distracted include a diversion of attention, yet the root of the word is traction. When our cognitive traction is diverted, it can cause us to potentially lose contact with the task we're performing, just as poor tire traction causes us to lose proper contact with the road. When you're distracted at the wheel, both the cognitive and physical can lose traction.

In spite of the well-known risks, it's estimated that 660,000 Americans use electronic devices while driving; 75% of Oregonians admit to driving distracted. The American Automobile Association (AAA) found that more than 40% of those between the ages of 19-39 admit to texting and driving at the same time. Did I mention that it quadruples the risk of an accident?

Sadly, it seems our efforts to address the issue have fallen short. Distracted driving laws, as well as the ANSI/ASSE Z15.1-2012 consensus standard have been instituted, in-dash technologies with voice activation have become common new car features, and yet we remain dis-*tracted*. In fact, it appears that the new in-dash technologies may actually be a greater distraction than cell phones because of the demand on our attention they require. Research shows that using voice commands while driving causes the driver to look, but not really see. The diversion of attention results is less scanning of road ahead and checking of rear-view mirrors, due to cognitive distraction. This perceptual blindness changes what we perceive, causing us to lose cognitive *traction*.

The best solution I've found is too put your phone on silence (not vibrate—you'll still hear it) and leave it in the back seat. You won't know what you're missing, so you won't miss it! Not only will you be less distracted in your driving, but you'll be better prepared to respond to what other, less -tracted drivers on the road may be doing.

New Distracted Driving Laws Are Now In Effect

Effective July 1, 2018, there are now stricter laws in Oregon state regarding the use of cell phones while driving. The new, tougher penalties, including increased consequences for repeat offenders, are part of a statewide effort to deter drivers from distracted driving.

Oregon Department of Transportation reports that there were nearly 11,000 crashes involving a distracted driver in Oregon state between 2012 and 2016, resulting in 70 fatalities and more than 16,000 injuries. Under the new rules, if the offense contributes to a crash or is the second offense, the fine could be as much as \$2500. First offenses are \$1000, if no crash occurs. Third time offenders, within a ten-year period, would be charged with a Class B misdemeanor, resulting in fines up to \$2,500 and 6 months in jail.

Distracted Drivers!

The Oregon Department of Transportation (ODOT) has partnered with LifeSaver to created a campaign with an app that blocks cell phone use when driving. The safety campaign gives companies, organizations, and schools the opportunity to compete to see who can drive the most safely.

Participating organizations create a DriveHealthy portal account used to invite drivers to install the LifeSaver App and participate as members of that organization or group. The free LifeSaver app scores drivers based on whether they unlock their phone while driving. Scores are posted and then reset each month. Friendly competition aside, it's a great way to track changes in behavior.

Research has shown that people are more likely to change behavior if they connect with others (the gym-buddy concept). Here's a great opportunity to create a little friendly competition between workers, friends, family members, youth groups, etc. Just download the app and start the fun!
